88 **Bid Conditions.** The bidder is required to provide all information as required within the Contract
89 Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed in
90 the Instructions to Bidders.

92 Bids may be held by City County Airport Commission for a period not to exceed 120 calendar days
93 from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

95 The right is reserved, as the City County Airport Commission may require, to reject any and all bids
96 and to waive any informality in the bids received.

102 **Bid Bond.** Guarantee will be required with each bid as a certified check on a solvent bank or a bid
103 bond in the amount of five (5) percent of the total amount of the bid, made payable to the City
104 County Airport Commission.

106 **Performance & Payment Bond.** The successful bidder will be required to furnish separate
107 performance and payment bonds each in an amount equal to 100% of the contract price.

109 **Airport and Airway Improvement Act of 1982 as amended.** In accordance with the Davis-
110 Bacon Act, as amended, the Contractor will be required to comply with the wage and labor
111 requirements and to pay minimum wages in accordance with the schedule of wage rates established
112 by the United States Department of Labor.

114 **Non-Segregated Facilities.** The successful bidder will be required to submit a certification of
115 Non-segregated Facilities and to notify prospective subcontractors of the requirement for such a
116 certification where the subcontract exceeds \$10,000.

118 **Equal Employment Opportunity and Affirmative Action Requirement.** The proposed
119 contract is under and subject to 41 CFR Part 60-4 and Executive Order 11246 of September 24,
120 1965, as amended, and to the equal opportunity clause and the Standard Federal Equal Employment
121 Opportunity Construction Contract specifications including the goals and timetables for minority
122 and female participation.
